# Who Are South Asian Americans?


SOUTH ASIAN AMERICANS ARE AMERICANS WHOSE

# How Does Caste Work?



### **ADIVASIS**

Indigenous people of South Asia. For self-determination and political/cultural autonomy, they fight against the stripping of their ancestral land and its natural resources.

### DALITS

Caste communities that were forced by Caste apartheid into slave and bonded agricultural labor, and undignified sanitation work like manual scavenging. Branded untouchable for jobs considered spiritually polluting, they struggle against extreme violence and discrimination.

### Key Conclusions for Caste-based Discrimination in the United States

It is clear from the findings of this report that Caste definitively exists in the diaspora. A summary of the data shows the scope of the problem. Caste in its manifestations has structural, interpersonal, and internal consequences that we must address.

- 25% of Dalits who responded said they had faced verbal or physical assault based on their Caste.
- ONE IN THREE Dalit students report being discriminated against during their education.
- TWO OUT OF THREE Dalits surveyed reported being treated unfairly at their workplace.
- 60% of Dalits report experiencing Caste-based derogatory jokes or comments.
- 40% of Dalits and 14% of Shudra respondents were made to feel unwelcome at their place of worship because of their Caste.
- 20% of Dalit respondents report feeling discriminated at a place of business because of their Caste.
- OVER 40% of Dalit Respondents have reported being rejected in a Romantic Partnership on the basis of Caste.
- ONE IN TWO of all Dalit respondents and ONE IN FOUR of all Shudra respondents live in fear of their Caste being "outed."

## REV WILLIAM BENTLEY DIARY EXCERPT

HAD THE PLEASURE OF SEEING FOR THE FIRST TIME A NATIVE OF THE INDIES FROM MADRAS. HE IS OF DARK COMPLEXION, LONG BLACK HAIR, SOFT COUNTENANCE, TALL, AND WELL PROPORTIONED. HE IS SAID TO BE DARKER THAN INDIANS IN GENERALOF HIS OWN CASTE. I HAD NOT OPPORTUNITY TO JUDGE HIS ABILITIES BUT HIS COUNTENANCE WAS NOT EXPRESSIVE. HE CAME TO SALEM WIHT CAPT.J GIBAUT AND HAS BEEN IN EUROPE.












# DUSKY PERII


### Keep the Hindus. Out, Says Weiter













31 July 1940

Dear Prof Dubois.

Although I have not met you personally, I know you by name as every one does who is working in the casue of securing liberty to the oppressed people. I belong to the Untouchables of India and perhaps you might have heard my name. I have been a student of the Negro problem and have read your writings throughout. There is so much similarity between the position of the Untouchables in India and of the position of the Negroes in America that the study of the latter is not only natural but necessary.

I was very much interested to read that the Negroes of America have filed a petition to the U.N.O. The Untouchables of India are also thinking of following suit. Will you be so good as to secure for me two or three copies of this representation by the Negroes and send them to my address. I need hardly say how very grateful I shall be for your troubles in this behalf.

My dear Mr. Ambedkar:

I have your letter concerning the case of the Negroes of America and the Untouchables in India before the United Nations. As you say a small organization of American Negroes, The National Negro Congress has already made a stat ment which I am enclosing. I think, however, that a much more comprehensive statement well documented will eventually be laid before the United Nations by the National Associatio for the Advancement of Colored People. If this is done I shall be glad to send you a copy.

I have often heard of your name and work and of course have every sympathy with the Untouchables of India I shall be glad to be of any service I can render if possiblin the future.

- 3 IN 5 WORKED AT LEAST 20-40 HOURS A WEEK OUTSIDE CLASSES.
- 2 IN 5 HAD TO APPLY FOR AN EMERGENCY LOAN FOR AN UNEXPECTED CRISIS OR EXPENSE.
- 4 IN 5 REPORTED EXPERIENCING CASTE DISCRIMINATION IN US HIGHER EDUCATION.

## Impacts of Caste Stress

- A sense of being isolated and an outside
- Low Self-worth and helplessness and hopelessness
- Stress related to being seen as a "representative" of one's community

- Feeling fearful, anxious, frustrated, helpless, depressed, or angry
- Considering dropping out or transferring to another school
- Difficulties with concentration and motivation for classes

### What Can Universities Do?

- ADD CASTE AS A PROTECTED CATEGORY IN YOUR INSTITUTIONS
- IMPLEMENT DIVERSITY AND INCLUSION TRAINING FOR HR, MANAGERS, AND STAFF TO BUILD CASTE COMPETENCY
- INVEST IN DALIT ORGANIZATIONS FOR EXTERNAL CONTRACTS

- HOLD A PUBLIC BRIEFING ON CASTE
- COLLECT DATA ON CASTE
   EXCLUSION TO SET KPI'S FOR
   MEASURING PROGRESS ON CASTE
   EQUITY
- CONDUCT A REVIEW OF PAST EXPERIENCES OF DALIT STAKEHOLDERS ON CAMPUS

## What Can Caste Equity Allies Do?

- COMMIT TO A GROWTH MINDSET THAT IS LIFETIME JOURNEY TO BUILDING INCLUSION
- MAP YOUR CONTEXT IN TERMS OF RACE, CASTE, AND GENDER
- USE PRECISE LANGUAGE AND ACTIONS AND REFLECT ON YOUR IMPLICIT AND EXPLICIT BIASES

- ADDRESS MICROAGRESSIONS BY
  UPSTANDING AND ENGAGE IN
  COMPASSIONATE
  INTERVENTIONS
- DON'T PUT THE BURDEN OF EQUITY ON THE EXCLUDED
- MEET WITH CASTE OPPRESSED
